Introduction

What is Trading Places?

Trading Places is an opportunity for environmental health, fire safety, licensing and trading standards officers to gain valuable insight into how businesses deal with regulation. In response to demand, this two-way learning experience is now provided in two formats.

Two-day format (suitable for larger businesses) – Day one gives a strategic overview of the business concerned, extending to its key functions and in particular the management of compliance. Day two is spent at the sharp end, looking at how customers are served and involving a range of practical activities.

One-day format (suitable for smaller businesses) – A group session for a number of businesses is coordinated by their trade association or representative body. It involves short presentations designed to encourage discussion of experiences of regulation, as well as exploration of ideas. It is followed up with learning visits to participating businesses at mutually convenient times.

By bringing together people from the private and public sectors, and through the involvement of national regulators, both formats promote shared learning. All the participants

have a great opportunity to appreciate alternative perspectives to business compliance, develop closer working relationships and find out more about the challenges and constraints both companies and local authority regulatory services face. Participants are encouraged to make advance preparations to get the most out of Trading Places, and afterwards to identify how their experiences can be applied to their future working practices.

The Local Better Regulation Office (LBRO) helps councils to improve the way they implement environmental health, fire safety, licensing and trading standards regulations. It is our responsibility to ensure that these vital public services are consistent, targeted, accountable, transparent and proportionate to risk.

We reduce unnecessary red tape for law-abiding businesses, to allow greater focus on targeting the rogue traders who harm vulnerable people and damage our communities. By making it easier for councils to advise on and apply the rules, and simpler for companies to understand them, we help to ensure that local regulation delivers both prosperity and protection.

Our duties include managing the Primary Authority scheme, advising central government on local regulation, providing statutory guidance and best practice to councils, and updating the list of national enforcement priorities for local government.

LBRO was established under the Regulatory Enforcement and Sanctions Act 2008 as a non-departmental public body, accountable to the Department for Business, Innovation and Skills (BIS) through the Better Regulation Executive.

We are governed by an independent Board and operate across the United Kingdom from our base in central Birmingham.
